### Warm-up Format Definition

**10 minute Warm-up-** applies to the first 2 matches of the pool play and the first match of bracket play. A 2-4-4 format will be used for the 10 minute warm-up. The first two minutes will be for ball handling, followed by 4 minutes on the court for the serving team and then 4 minutes for the receiving team.

**5 minute Warm-up-** applies to all other matches. A 1-2-2 format will be used for the 5 minute warm up.

**Format- Four (4) team pools.** Pool play will be 2 games rally scoring 25 points with a 27-point cap.

- If the two teams split their sets the team with the most favorable point differential will be awarded the match.
- If the two teams split their sets and the scores of the sets are the same resulting in a 0 point differential, an additional point would need to be played at the end of the second game.

**Example:** Team A wins set one 25-22, Team B wins set two 25-22, an additional point should be played in game two.

**10 minute Warm-up-** applies to the first 2 matches of the pool play and the first match of bracket play. A 2-4-4 format will be used for the 10 minute warm-up. The first two minutes will be for ball handling, followed by 4 minutes on the court for the serving team and then 4 minutes for the receiving team.

**5 minute Warm-up-** applies to all other matches. A 1-2-2 format will be used for the 5 minute warm up.

**Format- Four (4) team pools.** Pool play will be 2 games rally scoring 25 points with a 27-point cap.

- If the two teams split their sets the team with the most favorable point differential will be awarded the match.
- If the two teams split their sets and the scores of the sets are the same resulting in a 0 point differential, an additional point would need to be played at the end of the second game.

**Example:** Team A wins set one 25-22, Team B wins set two 25-22, an additional point should be played in game two.

**Playoffs** will begin after DAY 2 Pool is completed.

A playoff match is two out of three games to 25 pt., no cap. If a deciding game is needed it will be 15-point rally scoring, switch at 8 points and no cap.

## ***PLAYOFFS***

**Playoffs** will begin after DAY 2 Pool is completed. There will be no movement between buildings on day 2.

A playoff match is two out of three games to 25 pt., no cap. If a deciding game is needed it will be 15-point rally scoring, switch at 8 points (if coaches feel the court has an unfair advantage on one side) and no cap.
