- If rosters are not submitted in advance, COACHES MUST TURN IN A SIGNED ROSTER UPON ARRIVAL. Rosters may be from SportsEngine (with a USAV circle & OFFICIAL ROSTER labeled in the upper right hand corner and coaches/players showing as eligible) or an AES roster with current USAV member numbers. Teams will NOT be allowed to play without an official roster.
- Warmup: 2-4-4 minutes prior to team's first match (serving team, then receiving team); 3-3 minutes in subsequent rounds (no shared warmup, serve during your 3 minutes if desired)
- All matches are best of 3: Sets 1 & 2 to 25 pts, 3rd set to 15 (no cap). Badger Region tiebreaker Protocol #2 will be in effect (i.e. 2-way ties determined by head-to-head results; 3+ way ties determined by match%, set%, point differential...no playoff to determine bracket placement). R1 provided for every match. Officiating teams will be required to provide R2 (preferably a coach), 2 line judges, scorekeeper, libero tracker and a flip scorer. NO FOOD OR CELL PHONES are allowed at the scorers' table.
- Please bring your own warmup balls.
- Spectator admission is \$3.00; senior citizens and kids under 8 are admitted free. <u>No coolers</u> please. We have a full concession stand with food, snacks, Pepsi/Gatorade products and bottled water. CASH ONLY!
- No food or beverages are allowed in the gyms (except water). Teams who leave excessive garbage on their bench or their team area may be fined.
- Volleyball merchandise will be sold throughout the tournament. Major credit cards accepted.
- There will NOT be an athletic trainer on site; ice is available for emergencies only; bring your own first aid kit.
- UW-Eau Claire is not responsible for lost or stolen items.

Directions to McPhee:

From East: Exit I94 at Hwy 53 (Exit #70) North. Exit Hwy 53 onto Clairemont Ave./Hwy 12. Go West. Turn Right on University Dr. McPhee Center is on right. Park in lot on North end of building OR across Clairemont Ave. in the CVTC south lot (take footbridge over Clairemont to McPhee). You may also park in the CVTC pay lot for an hourly fee. From West: Exit I94 at Hwy 37 (Exit #65) and turn Right. Follow to Clairemont Ave. Go East. Turn Left on University Dr. and follow as above.

From Hwy 53: Exit Hwy. 53 onto Clairemont Ave./Hwy. 12. Go West. Turn Right on University Drive and follow as above.
